APOSTILLE

An Apostille is a certificate that is attached to notarized documents being sent to countries that are parties to the international treaty known as the Hague Convention Abolishing the Requirement of Legalization of Foreign Public Documents. This certificate allows the receiving country to accept the documents without lengthy and time-consuming authentication process.

The Hague Legalization Convention is in force in the following countries. On October 5, 1961 the several nations joined to create this simplified method of legalizing documents through the Hague Convention Abolishing the Requirement of Legalization for Foreign Public Documents.
